

General Website Privacy Policy

In this General Website Privacy Policy ("[Privacy Policy](#)"), Mirion Technologies (GDS), Inc. and its affiliates, ("[Mirion](#)," "[we](#)" or "[us](#)") provides information about how we collect, use, and transfer personal data from you, a website visitor, through www.instadose.com and other websites that we operate and on which we post a direct link to this Privacy Policy (collectively the "[Site](#)").

1. SCOPE

This Privacy Policy covers only data collected through the Site and not any other data collection or processing, including, without limitation, data collection practices of other web pages to which we link or data that we collect offline or through websites that do not display a direct link to this Privacy Policy. 2. COLLECTION PURPOSES, USE OF DATA

We collect *passively tracked data* primarily for purposes of administering, protecting and improving our Site and our systems, to better understand the preferences of our Site visitors, to identify server problems, to compile aggregated statistics about Site usage, and to help personalize your experience of our Site.

We collect *actively submitted data* primarily for two purposes: firstly, for the purpose for which you originally sent us the data (*e.g.*, to send information to you); and secondly, for purposes of informing you about products, services and events; you can opt-out of receiving marketing emails as explained below.
